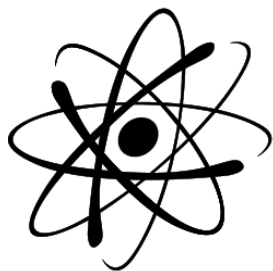

GENERAL INFORMATION: NRG™-KS is a liquid fertilizer solution. NRG-KS is designed for use in the promotion of new growth.

DIRECTIONS FOR USE: NRG-KS should be used based on soil and tissue analyses in accordance with the recommendation of a qualified person or institution such as a certified crop consultant, agronomist, university crop extension publication or apply according to recommendations in your approved nutrient plan. General application rate is 2.5 L/Ha (1 L/Ac).

COMPATIBILITY: Tank mix compatibility is impacted by water quality which may vary by location. DO NOT mix NRG-KS in a concentrated form with other fertilizers or pesticides. When mixing always ensure adequate dilution in the spray tank before adding NRG-KS. A standard jar test is recommended prior to mixing with other fertilizers or pesticides.

HANDLING: Product is stable, non-flammable and non-explosive. DO NOT FREEZE. If spillage occurs, recover and reuse. Dispose of this product in accordance with federal/provincial/municipal regulations.

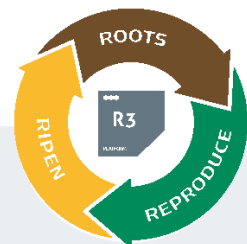
